1. The tenure of contract appointment will be 3 years.
2. The contract of appointment may be terminated by either side giving 3 months' notice or by paying the contractual remuneration of three months in lieu of notice period, if the circumstances so warrant.

IV. CONDITIONS:

1. Candidates who have been shortlisted will only be called for interview.
2. The experience should be post qualification and is a minimum requirement. Mere possession of minimum experience does not confer any right to be called for interview / selection.
3. Any canvassing by or on behalf of the candidates or to bring political or other outside influence with regard to selection/appointment shall be a disqualification.
4. Selection will be through interview by a Committee constituted by the Competent Authority.
